Shri Pankaj Kumar Gupta, Adv. has put in appearance on behalf of the respondent No.2.

Heard learned counsel for the parties at Bar. Perused the material available on record.

Having gone through the contents of the impugned FIR, this Court finds it just and appropriate to direct the Investigating Officer not to arrest the petitioners till the next date of hearing in connection with the FIR No.186/2025, registered at Police Station Suratgarh, District Ganganagar for the offences under Sections 420, 406 and 120-B of IPC.

At this stage, learned counsel for the parties submit that there is a possibility of settlement of dispute between the parties, therefore, the matter be referred to the Mediation Center of this High Court.

In view of the request made, Office is directed to refer the matter before the Mediation & Conciliation Center of this High Court. The parties are directed to appear before the Mediation & Conciliation Center of this High Court on 19.05.2025 so as to explore the possibility of a mutual settlement. The Mediator concerned shall forward the report of proceedings to this Court on 21.05.2025.

List the matter on 23.05.2025.
