Learned counsel for the petitioner submits that the petitioner would be satisfied if a direction is issued to respondent No. 4 – Tehsildar, Jaitaran, District Pali, to consider and decide the

petitioner's application/representation within a stipulated time period.

In view of the aforesaid submission, and without expressing any opinion on the merits of the case, the present writ petition is disposed of with liberty to the petitioner to file a fresh application/representation, before respondent No. 4 – Tehsildar, Jaitaran, District Pali, within a period of two weeks from today. Upon receipt thereof, respondent No. 4 shall consider and decide the petitioner's application/representation strictly in accordance with law within a period of six weeks thereafter.

It is made clear that the aforesaid direction has been issued only to ensure expeditious consideration of the petitioner's grievance and shall not be construed as an expression of opinion on the merits of the case or as a direction to decide the application/representation in a particular manner.

The present writ petition is disposed of accordingly.

Stay application and all other pending applications, if any, also stand disposed of.
