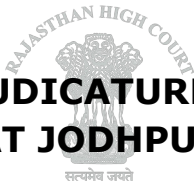

- The present temporary suspension of sentence application has been filed by the applicant under Section 430 BNSS (389 of Cr.P.C.) seeking temporary suspension of sentence awarded to him by learned Addl. Sessions Judge No.2, Sriganganagar, (hereinafter referred to as 'trial Court') vide order dated 01.04.2025 passed in Session Case No.20/2023 (CIS No.45/2023), for ailment of his parents.
- Learned counsel for the applicant submits that applicant's parents are ill and they are required to be treated at a higher center. Learned counsel for the applicant submits that there is no

other male member in the family to take care of well being his parents, therefore, the application for temporary suspension of sentence may be allowed and the applicant's sentence may be suspended temporarily for a period of 30 days.

3. Learned Addl. Advocate General has filed the verification report dated 05.08.2026 affirming the statements and averments made by the counsel for the applicant.

4. We have considered the submissions made at the bar and have gone through the relevant record of the case.

5. In view of the aforesaid, the present application seeking temporary suspension of sentence is allowed and it is ordered that the substantive sentence passed by the learned trial court vide judgment dated 01.04.2025 passed in Session Case No.20/2023 (CIS No.45/2023) against the applicant –**Vinay Kumar S/o Gulab Ram Kumhar** shall remain temporarily suspended for a period of **30 days** from the date of his actual release provided he executes a personal bond in the sum of Rs.1,00,000/- (Rupees One Lakh Only) with two sureties in the sum of Rs.50,000/- (Rupees Fifty Thousand Only) out of which one surety will be of his close relative, each to the satisfaction of the concerned Jail Superintendent on usual conditions. He shall surrender back before the concerned Jail Superintendent after completion of **30 days** from the date of his actual release. The concerned Jail Superintendent shall give a date of his surrender.

6. Let this application seeking interim suspension of sentence be again listed on **10.09.2026**, and on that date, learned Public



Prosecutor and learned counsel for the petitioner shall submit the compliance of this order.
