ORDER

21/05/2026

1. Mr. Manoj Bhandari, learned Senior Counsel assisted by Mr. Aniket Tater, appearing on behalf of the petitioners, has drawn attention of this Court to the order dated 15.04.2026 (Annexure-6) passed by a Coordinate Bench of this Hon'ble Court in ***Dr. Sunil Bishnoi & Ors. v. State of Rajasthan & Ors. (D.B. Special Appeal Writ No.1329/2025)***, which is reproduced hereunder:

"1. Issue notice to the respondents.

2. Learned counsel for the appellants submits that the appellants are working in the college and are being removed after every session and fresh appointments are given.

3. We notice that the State Government has virtually shifted the Higher Education Department to a Society. The colleges which were earlier under the Rajasthan Education Services (Collegiate Branch) Rules, 1986 have been shifted by forming a Society under the Societies Registration Act, 1958, which would make

the Service Rules otiose and the proviso to Article 319 of the Constitution redundant. Prima facie the order dated 11.07.2022 (Annx. 7) passed by the State Government forming Rajasthan College Education Society appears to be contrary to the ethos of the Constitution.

4. Let learned Advocate General appear and make submission as to why the formation of Rajasthan College Education Society should not be declared illegal.

5. Meanwhile, the appellants shall continue to perform their work as guest faculties even for the next session.”

2. Yesterday, Mr. Jala, learned counsel appearing on behalf of the respondents, submitted that an Additional Affidavit has been filed on behalf of the respondents in respect of the aforementioned order, and sought an adjournment of one day for the purpose of placing the said Additional Affidavit before this Hon'ble Court.

3. Today, this Court has carefully examined the said Additional Affidavit, which does not constitute an adequate or satisfactory answer to the specific question framed by the Coordinate Bench of this Hon'ble Court, which was material in the context of the grave constitutional concern raised by the Court namely, that the Rajasthan Education Services (Collegiate Branch) Rules, 1986 were being circumvented under the garb of creation of a Society under the Societies Registration Act, 1958, thereby undermining and eroding the constitutional framework enshrined under Article 309 of the Constitution of India.

4. The said additional affidavit submitted by learned counsel for the respondents is taken on record in this matter as well.

5. This Hon'ble Court, being not satisfied with the contents of the Additional Affidavit, proceeded to pose further questions to the

learned counsel for the Respondents, who endeavoured to impress upon this Court that any interference with the impugned Advertisement at this stage would gravely jeopardize the ongoing academic sessions, which are presently burdened with a significant number of vacancies.

6. However, the learned counsel for the Respondents could not satisfactorily address this Court as to the precise manner and procedure by which such vacancies are sought to be filled, particularly in light of the substantive constitutional questions raised by the Co-ordinate Bench of this Hon'ble Court.

7. Learned counsel for the respondents however, shown another order dated 07.05.2026 passed by a Coordinate Bench of this Hon'ble Court in D.B. Civil Writ Petition No.8327/2026 (Vidhya Sambal Assistant Professor Association v. State & Ors.), wherein the process of Raj-CES recruitment has been made subject to final outcome of the said writ petition.

8. This Court, on being completely dissatisfied with the stand of the respondents-State in relation to the order dated 15.04.2026 passed by this Hon'ble Court in D.B. Civil Special Writ No.1329/2025 (Dr. Sunil Bishnoi v. State of Rajasthan), as also with the additional affidavit placed on record, deems it appropriate to grant further time to the respondents to respond. The respondents may respond on or before next date of hearing.

9. List this case on 25.05.2026 along with DBSAW No.1329/2025.

10. However to maintain the judicial propriety, this Court has passed the same relief as passed vide order dated 07.05.2026 in D.B. Civil Writ Petition No.8327/2026 (Vidhya Sambal Assistant Professor Association v. State of Rajasthan & Ors.).

11. In the meanwhile, instead of staying the selection process on the post of Teaching Associate on contractual basis under the Rules of 2023, pursuant to the impugned notification dated 30.04.2026, we deem it just and proper to observe that the selection process shall remain subject to the order dated 07.05.2026 passed in DBSAW No.8327/2026. It is also hereby observed that if any associate member of the petitioner-Society, participates in the selection process, same would not adversely affect the challenge made by the petitioner to the Rules of 2023 and notification dated 30.04.2026.

12. However, the affidavit submitted by the respondents-State in Dr. Sunil Bishnoi & Ors. v. State & Ors. is hereby taken on record.
