Heard learned counsel for the parties.

It is not possible to hear these petitions today. However, learned Advocate General pressed for vacation of the interim orders.

This Court is of the opinion that at this stage having regard to the entire facts and circumstances of the case, especially the fact that interim orders are operating as on date, it would not be appropriate to vacate the interim orders. Nevertheless, in case the writ petitions are held to be without merit and the challenge fails, apart from the other remedies, the State shall also be entitled to claim interest @ 18% per annum, in over and above the amount due and payable by the petitioners.

Learned counsel for the petitioners requested to facilitate hearing through Video Conferencing, since counsel in many of these petitions are at Jaipur and those writ petitions have to be transferred from Jaipur Bench. This request may be made at least a week before the hearing.
