CRLMP No.5269/2026 :-

Counsel for the petitioner submits that petitioner is Bank Manager and in fact first information regarding the fraud was given by him to police & the Department and thereafter the FIR has been registered, however, he is being un-necessarily involved into this FIR although he had busted the entire scam.

The matter requires interference.

Issue notice.

Learned Public Prosecutor accepts notice on behalf of respondent-State. Notice, thus, is required to be issued to respondent no.2 only, returnable within a period of three weeks.

In the meantime, the petitioner shall not be arrested in connection with FIR No.80/2026 registered at Police Station, Pallu, District Hanumangarh. However, petitioner shall be required to join investigation.

CRLMP No.4091/2026 :-

Counsel for the petitioner submits that the petitioners are in no way involved in the alleged fraud pertaining to the Pradhan Mantri Fasal Bima Yojana (PMFBY) crop insurance scheme. He further submits that the petitioners neither upgraded any premium nor received any amount in their respective bank accounts and that, in fact, their identities have been misused in the alleged scheme.

The matter requires interference.

Issue notice.

Learned PP accepts notice on behalf of respondent-State. Mr. Deepak Bora accepts notice, thus, notice need not be issued afresh.

In the meanwhile, the petitioners shall not be arrested in connection with FIR No. 80/2026 registered at Police Station Pallu, District Hanumangarh. However, the petitioners shall be required to join investigation.

CRLMP No.4380/2026 :-

Learned PP is directed to call for the case diary.

List after three weeks.

CRLMP No. 5270/2026:

Counsel for the petitioner submits that the petitioner is agriculturists and in no way involved in the alleged fraud pertaining to the Pradhan Mantri Fasal Bima Yojana (PMFBY) Crop Insurance Scheme.

The matter requires interference.

Issue notice.

Learned Public Prosecutor accepts notice on behalf of respondent-State. Notice, thus, is required to be issued to respondent no.2 only, returnable within a period of three weeks.

In the meanwhile, the petitioner shall not be arrested in connection with FIR No. 80/2026 registered at Police Station Pallu, District Hanumangarh. However, the petitioner shall be required to join investigation.
