SB Criminal Misc. Petition No.5784/2026:-

The present criminal miscellaneous petitions have been filed by the petitioners under Section 528 of the Bharatiya Nagarik Suraksha Sanhita, 2023, seeking quashing of FIR No. 80/2026 registered at Police Station Pallu, District Hanumangarh.

Learned counsel for the petitioners submits that the petitioners are in no way involved in the alleged fraud relating to the Pradhan Mantri Fasal Bima Yojana (PMFBY) crop insurance scheme. He further submits that the petitioners neither enhanced the insurance premium nor received any amount in their respective bank accounts and that, in fact, their identities have been misused in the alleged scheme.

Learned Public Prosecutor is directed to call for the case diary by the next date of hearing.

Put up on 10.08.2026.

In the meanwhile, the petitioners shall not be arrested in connection with **FIR No. 80/2026** registered at Police Station Pallu, District Hanumangarh.
