This Criminal Miscellaneous Petition under Section 528 of the Bharatiya Nagarik Suraksha Sanhita, 2023 has been preferred on behalf of the petitioners seeking quashing of FIR No.180/2026 registered at Police Station Anupgarh, District Sriganganagar.

After arguing the matter on merits for some time, learned counsel for the petitioners submits that he does not wish to press the present Criminal Miscellaneous Petition; however, he seeks liberty for the petitioners to submit an appropriate representation along with supporting evidence before the concerned Investigating Officer.
