1. The matter comes upon an application (I.A. No.01/2026) for interim bail filed by the petitioner under Section 483 of BNSS (old Section 439 of Cr.P.C.). The requisite details of the matter are tabulated herein below:

2. Learned counsel for the petitioner submits that the petitioner has applied for Senior Teacher (Sec. Edu. Department) Competitive Exam, 2025 and the exam is scheduled to be held on 14.07.2026 in two shifts i.e. from 10.00 AM to 12.00 PM and 3.00 PM to 05.30 PM. There are no criminal antecedents against the

petitioner. Therefore, petitioner may be granted interim bail for one day i.e. on 14.07.2026.

3. Learned Public Prosecutor vehemently opposes this application for interim bail.

4. Heard learned counsel for the petitioner and learned Public Prosecutor and perused the material available on record.

5. Considering the submissions made above and the fact that the examination of the petitioner for Teacher Grade II is scheduled on 14.07.2026, this Court deems it just and proper to grant interim bail to the petitioner for one day i.e. on 14.07.2026.

6. Accordingly, this application for interim bail filed under Section 483 of BNSS is allowed. It is ordered that petitioner- **Babulal S/o Shri Amarchand**, shall be released on bail in police custody for one day i.e. on 14.07.2026 in connection with the aforesaid FIR.

7. The petitioner shall surrender on the same day i.e. 14.07.2026, after completion of his examination.

8. Learned counsel for the petitioner shall pay the necessary charges for providing police assistance.

9. Let this bail application be again listed on **16.07.2026** Learned Public Prosecutor shall be required to submit the compliance report of the order as to whether the petitioner has surrendered or not.
