This application for bail under Section 483 BNSS (439 Cr.P.C.) has been filed by the petitioner who has been arrested in connection with F.I.R. No.195/2026, registered at Police Station Ratangarh, District Churu, for offences under Sections 8/20 and 8/29 of the NDPS Act.

Learned counsel for the petitioner submitted that the contraband allegedly recovered from the petitioner is 1.274 kg of Ganja, which is below the commercial quantity prescribed under the law. Learned counsel further submitted that the petitioner has no criminal antecedents. It was contended that FIR No. 194/2026 was registered on the same date as the present FIR, which is evident from the FIR number itself; therefore, the said FIR cannot be treated as an antecedent against the petitioner. Learned counsel further submitted that the petitioner has been in judicial custody since 17.05.2026, the investigation qua the petitioner has

been completed, and the trial is likely to take considerable time to conclude. Accordingly, it was prayed that the benefit of bail be granted to the accused-petitioner.

Per contra, learned Public Prosecutor has opposed the bail application.

This Court has considered the rival submissions advanced by the learned counsel for the parties, and has also perused the material available on record. The contraband allegedly recovered from the petitioner is 1.274 kg of Ganja, which is below the commercial quantity prescribed under the law. The petitioner has no criminal antecedents. The FIR No. 194/2026 was registered on the same date as the present FIR, which is evident from the FIR number itself. The petitioner has been in custody since 17.05.2026, and the investigation qua the petitioner has been completed. The trial of the case is likely to take considerable time to conclude. Accordingly, without expressing any opinion on the merits or demerits of the case, this Court is inclined to enlarge the petitioner on bail.

Consequently, the bail application under Section 483 BNSS (439 Cr.P.C.) is allowed. It is ordered that the accused-petitioner **Teekuram S/o Suresh Kumar** arrested in connection with FIR No.195/2026, registered at Police Station Ratangarh, District Churu, shall be released on bail, if not wanted in any other case, provided he furnishes a personal bond of Rs.1,00,000/- and two sureties of Rs.50,000/- each, to the satisfaction of learned trial court, for his appearance before that court on each & every date

of hearing and whenever called upon to do so till completion of the trial.
