1. Learned counsel for the petitioners submits that on 21.09.2023, counsel for the respondents had undertaken before the Court not to pursue the execution proceedings before the Executing Court till the next date. In view of the undertaking given by counsel for the respondents, the matter was adjourned and the undertaking as given by the counsel was continued on 29.07.2024 and further on 23.09.2024. However, the matter was then referred to mediation but as the mediation failed, the petition has again been listed before the Court.

2. Learned counsel submits that as the undertaking has not been extended on the dates subsequent to 23.09.2024, the learned Executing Court has proceeded further and has refused to adjourn the proceedings.

3. In view of the fact that the undertaking as given by counsel for the respondents was extended on 29.07.2024 and further on 23.09.2024 and subsequent to that the matter was only listed once before the Court that too, with the report that mediation has failed; and further there being no statement on behalf of the counsel for the respondents to revoke his undertaking, it is hereby directed that the Executing Court shall not proceed with the matter till the next date.
