1. Learned counsel for the petitioner submits that in similar
controversy the Coordinate Bench of this Court in **SBCWP
No.14344/2023: Babu Ram Vishnoi Vs. State of Rajasthan
& Ors.** vide order dated 21.09.2023 has granted interim order
while issuing notices to the respondents. The order dated
21.09.2023 is reproduced as under:-

"1. Learned counsel for the petitioner places reliance
upon the order dated 28.02.2023 passed by Co-

ordinate Bench of this Court in S.B. Civil Writ Petition No.3195/2023 (Pokar Ram Vs. State of Rajasthan & Ors.).

2. Learned counsel for the petitioner has shown letter dated 01.07.2008, by which, they were given recruitment, in which, the age limit was 65 years. He has also referred to Rule 256 Sub Rule (E) of the Rajasthan Panchayati Raj Rules 1996.

3. Issue notice to the respondents, returnable on 30.10.2023.

4. In the meanwhile, the respondents are directed to continue the services of the petitioner on the post of Junior Technical Assistant in Panchayat Samiti Tinwari, District Jodhpur.

5. Connect with SBCWP No.3195/2023 & 8302/2023."

2. In view of the above, issue notice to the respondents. Issue notice of the stay application as well.

3. In the meanwhile, the respondents are directed to continue the services of the petitioner on the post of Junior Technical Assistant in Panchayat Samiti Bhopalgarh, District Jodhpur.
