The present petition has been filed assailing the order dated
06.06.2026, issued by R.B. Distribution Samiti.

He has submitted that the same is passed in violation of principles of natural justice, without supplying memo of appeal to the petitioner, which was asked for by legal notice; moreover, no reasonable opportunity of hearing was granted to the petitioner.

Learned counsel for the respondent has submitted that the petitioners' plea may be decided afresh by the respondents, and a speaking order shall be passed upon doing the needful within a period of thirty days.

In the light of the arguments submitted by learned counsel for the respondent, This Court deems it appropriate and thus hereby quashes and sets aside the impugned order (annexure-17) dated 06.06.2026. Further, it is directed to the respondents that the plea of the petitioner be considered afresh, and speaking orders thereto be passed, within a period of thirty days from date of making of such plea.

Till final consideration by the respondents is made, status *quo*, as on date, be maintained by the parties.

Accordingly, the present petition is disposed of. Pending applications if any, shall stand disposed.
