At the outset and after arguing for a while, learned counsel for the petitioners has cited the judgment dated 30.01.2019

passed by the Co-ordinate Bench of this Court in a bunch of writ petitions led by **Gopal Purohit Vs. State of Rajasthan & Ors. : S.B. Civil Writ No. 3461/2018** and submitted that the present petitions can be decided likewise.

Heard and perused the material available on record.

The arguments that the writ petition can be entertained is duly considered by this Court, but the same is not found to have any substance for the grounds stated herein:-

(i) Disputed questions of facts are involved and writ court ought not to invoke its jurisdiction to entertain disputed question of facts unless there are extra-ordinary circumstances and apparent violation of principles of natural justice and infringement of fundamental rights.

(ii) The present matter pertains to a special law therein special provisions are enumerated, needless to say that it is a trite law that in case of general provisions versus special provisions, the latter shall prevail. In the matter at hand, the same being the provisions of Motor Vehicles Act, 1988.

For the reasons noted hereinabove and for availability of alternative efficacious remedy, the present petitions are dismissed.

Pending applications, if any, also stand disposed of.
