This criminal misc. petition under Section 528 BNSS has been preferred on behalf of the petitioners seeking quashing of FIR No.06/2026 registered at Police Station Chopasani Housing Board, District Jodhpur City West.

After attempting to argue the matter on merits for quite some time, learned counsel for the petitioners has submitted that he does not want to press this criminal misc. petition, however

seeks liberty for the petitioners to move appropriate representation along with the supporting evidence before the Investigating Officer.
