It is submitted by learned counsel for the petitioner that petitioner was recruited as Forest Guard by order dated 13.4.2011 and was accorded posting in Non-TSP area.

On 11.4.2017, final seniority list as on 1.4.2017 was issued for Non-TSP area, wherein name of the petitioner was reflected. However, it is claimed that on an option given by the petitioner under Rules of 2014 opting for TSP area, her name was included in the provisional seniority list dated 1.4.2019 (Annex.4) for TSP area.

Whereafter, she was accorded promotion on 30.4.2019 (Annex.5) on the post of Assistant Forester in TSP area.

Whereafter, in the final seniority list dated 8.6.2020 meant for TSP-area, name of the petitioner was reflected. However,



suddenly in the list dated 5.8.2022 (Annex.7) meant for Non-TSP area, the name of the petitioner was included and objections were sought. The petitioner filed objection, however, without considering the objection, the final seniority list of Assistant Forester has been issued as on 1.4.2020, wherein name of the petitioner has been reflected in the Non-TSP area.

Again a provisional seniority list has been issued on 18.8.2022 (Annex.10) by the respondents of Assistant Forester for Non-TSP area, wherein also the name of the petitioner has been reflected qua which the petitioner has already raised objections.

Submissions have been made that once the petitioner has been accorded promotion on the post of Assistant Forester in the TSP area, including the name of the petitioner in the list of Assistant Forester for Non-TSP area is not justified, the same is contrary to the Rules of 2014.

In view of the submissions made, issue notice. Issue notice of the stay application also, returnable in four weeks.

In the meanwhile and until further orders, effect and operation of the final seniority list 16.8.2022 (Annex.9) and further proceedings pursuant to the provisional seniority list dtd.18.8.2022 (Annex.10), shall remain stayed.
