Heard learned counsel for the parties.

The present habeas corpus petition has been filed by the father of the corpus Mst. 'R' alleging therein that she is in illegal detention of the respondent No.5.

3. In pursuance of the directions issued by this Court, the corpus Mst. 'R' has been produced before us.

4. We have conferred with the corpus Mst. 'R'. The corpus Mst. 'R' has stated that she is 23 years of age and she understands her well-being quite well. She has further stated that she went with respondent No.5 of her own free will. She has also stated that now she wants to go with the present petitioner.

5. We have considered the statements made before us and we are of the view that since the corpus Mst. 'R' is a major lady understands her well-being quite well, therefore, she is free to live at a place of her own choice.

6. In view of the discussion made above, the present habeas corpus petition is disposed of with a direction to the investigating agency to allow the corpus to go and live at a place of her own choice.

7. The investigating agency is further directed to provide adequate security to the corpus Mst. 'R' till she reaches the place of her choice.
