1. Learned counsel for the petitioner submits that the petitioner was placed under suspension vide order dated 07.05.2026 (Annex.2). Subsequently, vide order dated 15.06.2026 (Annex.3), suspension order issued against the petitioner was revoked.
2. The grievance of the petitioner is that without indicating any administrative exigency, the respondents, vide the same very order dated 15.06.2026, transferred the petitioner from Rajsamand to Kota, which is approximately 300 kms away from his present place of posting.

3. Learned counsel for the petitioner submits that petitioner can ill-afford his re-location given that he has to look after his family who is dependent on him and will have to necessarily move along with him which will add to his monthly expenses in the meager salary which he gets.
4. In view of the above, issue notice of the writ petition along with stay application to the respondents.
5. In the meanwhile, effect and operation of the order dated 15.06.2026 (Annex.3) issued by respondent No.2-The Executive Director (Administration), Rajasthan State Road Transport Corporation, Parivahan Bhawan, Parivahan Marg, Jaipur, transferring the petitioner from Rajsamand to Kota, shall remain stayed qua the petitioner and petitioner shall be permitted to discharge his duties as Conductor at Rajsamand Depot.
6. However, it is made clear that in case the petitioner can be accommodated in or around Rajsamand within the same District, the respondents shall be at liberty to pass fresh orders.
8. Connect with SBCWP No.11286/2026, as prayed.
