1. The present bail application under Section 483 of BNSS is filed by the applicant-accused **Mukesh S/o Shri Ram Chander**, seeking bail in respect of a criminal case registered as FIR No.146/2026 dated 09.06.2026 registered at P.S. Mukta Prasad Nagar, District - Bikaner, for the offence under Sections 109(1), 115(2), 126(2), 324(2), 333 & 189(2) and Section 27 of Arms Act.
2. Learned counsel for the applicant submits that the applicant has been falsely implicated in the matter and the investigation against him is complete and he is no more required in investigation. He further submits that there are no chance of fleeing of applicant accused from the

jurisdiction of this Hon'ble Court. He also submits that the applicant undertakes not to repeat offence and cooperate with trial, which will take time.

3. Learned counsel for the petitioner submits that on similar charges, a cross FIR No.147/2026 was registered by father of petitioner against the complainant of the current FIR and the contents as mentioned in cross FIR clearly indicate that the complainant party has assaulted with firearms and the present petitioner has sustained injuries. He further submits that in the instant case, no one has sustained injury.
4. Learned Public Prosecutor and learned counsel for the complainant have vehemently opposed the bail application and submitted that the allegations are grave and serious in nature.
5. Heard learned counsel for the parties and learned Public Prosecutor. Perused the material placed on record by both the parties.
6. The complainant Sandeep Swami has lodged a report of alleged house trespass and to attempt murder in the evening of 8th June 2026, opened a fire and FIR No.146/2026 was registered at P.S. Mukta Prasad Nagar, District – Bikaner. A cross FIR No. 147/2026 was also registered by father of the present petitioner. We have considered the case diary and also the statements of witnesses recorded by police in relation to the investigation in both the cases. No one has sustained any injury in the instant case.
7. Upon hearing the arguments and perusing the record, we have found that the applicant-accused is no more required in

the investigation and he is in custody for quite some time. The further proceedings will take its own time, therefore, looking to entirety of facts and circumstances of the case and without expressing any opinion on merits of the case, the Court deems it appropriate to grant bail to the applicant-accused.

8. Thus, the instant bail application filed on behalf of applicant-accused **Mukesh S/o Shri Ram Chander**, is hereby allowed and the applicant-accused is ordered to be released on bail upon furnishing a personal bond of ₹50,000/- with two sureties of like amount to the satisfaction of the Trial Court with the following conditions:-

- (i) The applicant-accused shall not tamper with evidence or influence the witness in any manner.
- (ii) The applicant-accused shall not indulge in any criminal activity and shall not repeat any criminal offence punishable under the Law.
- (iii) The applicant-accused shall attend the hearing of the Trial Court on the date fixed by the Trial court or as and when asked to appear before the Trial Court.
- (iv) In case of any violation of above conditions, the bail granted to the applicant-accused shall be liable to be canceled.

9. The Registry is directed to send a copy of this order to the Trial Court through E-mail.
