Learned counsel for the petitioners submits that the case pertains to monetary transaction and the allegation is that the registered sale-deed was not executed pursuant to the agreement. Hence, the dispute is purely civil in nature.

In view of the same, this Court is inclined to interfere in the matter.

Issue notice.

Learned Public Prosecutor accepts notice on behalf of the respondent – State.

Mr. Surendra Thanvi, learned counsel accepts notice on behalf of the respondent No.2.

In the meanwhile, the petitioners shall not be arrested in connection with FIR No.192/2026, registered at Police Station Kotwali, District Banswara. However, the petitioners shall be required to join the investigation.

Looking to the fact that there are cross FIRs in the matter and in view of the submissions made, the matter is referred to the Mediation Centre attached to this Court.

The parties shall appear before the learned Mediator on 21.07.2026.

List the matter again on 05.08.2026.

The Registry is directed to communicate a copy of this order to the Mediation Centre forthwith.
