1. The present temporary suspension of sentence application has been filed on behalf of the applicant under Section 430 BNSS (389 of Cr.P.C.) seeking temporary suspension of sentence on account of death of his father.
2. Learned counsel for the applicant submits that the father of the applicant has died on 28.06.2026. He, therefore, prays that the sentence awarded to the applicant may be temporarily suspended for a period of 15 days to participate in the last rites ceremonies of his father.
3. Learned Public Prosecutor has verified the factum of the death of the father of the applicant through the local SHO. He has submitted a report dated 02.07.2026.



4. The report dated 02.07.2026 is taken on record.
5. We have considered the submissions made at the bar and have gone through the relevant record of the case.
6. In view of the aforesaid, the present application seeking temporary suspension of sentence is allowed and it is ordered that the substantive sentence passed by the learned Sessions Judge, Balotra vide judgment dated 07.05.2026 passed in Session Case No.28/2018 (CIS No.50/2018) against the applicant – **Sohan Singh S/o Dhan Singh** shall remain temporarily suspended for a period of 15 days' from the date of his actual release provided he executes a personal bond in the sum of Rs.1,00,000/- (Rupees One Lakh Only) with two sureties in the sum of Rs.50,000/- (Rupees Fifty Thousand Only) out of which one surety will be of his close relative, each to the satisfaction of the concerned Jail Superintendent on usual conditions. He shall surrender back before the concerned Jail Superintendent after completion of 15 days' from the date of his actual release. The concerned Jail Superintendent shall give a date of his surrender.
7. Let this application seeking temporary suspension of sentence be again listed on **27.07.2026** and on that date, learned Public Prosecutor and learned counsel for the petitioner shall submit the compliance of this order.
