1. The petitioner has been arrested in connection with F.I.R. No.347/2017, Police Station Rajgarh, District Churu for the offence punishable under Sections 302, 147, 148, 149, 34 and 120 of IPC. He has preferred this interim bail application under Section 439 of Cr.P.C.
2. Heard learned counsel for the parties. Perused the material on record.
3. Learned counsel for the petitioner submits that petitioner's father has died on 04.07.2026 and, therefore, he being the son is required to participate in the last rites ceremonies of his father. He, therefore, prays that the applicant may be enlarged on interim

bail for a period of 60 days.

4. Learned Public Prosecutor has got the verification done of the death of the petitioner's father on 04.07.2026.

5. The report dated 04.07.2026 is taken on record.

6. Having regard to the totality of the facts and circumstances of the case, this Court deems it just and proper to grant interim bail to the petitioner under Section 439 of Cr.P.C. for a period of two weeks from the date of his actual release.

7. Accordingly, the interim bail application filed under Section 439 of Cr.P.C. is allowed and it is directed that petitioner- **Ravindra Alias Mintiya S/o Sh. Jale Singh** shall be released on interim bail for a period of two weeks from the date of his actual release, provided he furnishes a personal bond in the sum of Rs.50,000/- (Rupees: Fifty Thousand Only) along with two sureties of Rs. 25,000/- (Rupees: Twenty Five Thousand Only) each to the satisfaction of the concerned Jail Superintendent on usual conditions. He shall surrender back before the concerned Jail Superintendent after completion of two weeks from the date of his release. The concerned Jail Superintendent shall give a date of his surrender.

8. Let this interim bail application be again listed on 03.08.2026, and on that date, learned Public Prosecutor and learned counsel for the petitioner shall submit the compliance of this order.
