1. Learned counsel for the petitioner submits that the issue raised in the present writ petition pertains to the grant of permission to undertake the counselling of B.Sc. Nursing course for the academic session 2026-2027. He further submits that the controversy involved in this matter is identical to the writ petition bearing S.B. Civil Writ Petition No. 13595/2026.

2. Learned counsel for the petitioner further submits that the NOC has duly been granted to the petitioner-Institution vide order dated 04.07.2025 (Annexure-2); however, the same is subject to

confirmation upon completion of the physical inspection by the District Level Inspection Committee for affiliations from Rajasthan Nursing Council (RNC)/Rajasthan University Of Health Science (RUHS).

3. It is further submitted that respondent No. 3 – Marwar Medical University, has issued the online notification notifying fourth week of July, 2026 for counseling and allotment schedule.

4. The matter requires consideration.

5. Issue notice to the respondents of the writ petition as well as of the stay petition, returnable within six weeks.

6. In the meantime, the respondent No.3 – Marwar Medical University is directed to allow the petitioner-Institution to participate in the counselling process conducted for admissions to the B.Sc. Nursing course for the academic session 2026–2027 as and when the counselling starts. Needless to observe that the participation of the petitioner shall be subject to the final outcome of the writ petition and while giving admission to the students, a clear stipulation shall be made by the petitioner-Institution that the admission being given to them is provisional.

7. The students so admitted shall be provisionally enrolled by the respondent-University.
