1. Heard.
2. Learned counsel for the petitioner submits that the petitioner has been engaged by the respondents on a contractual basis as Teaching Associate at the Centre for Conservation of Animal Biodiversity, Rajuwas, Bikaner since 2022 and was subsequently re-appointed by various orders issued by the respondents. He further submits that the respondents renewed the petitioner's contract for the years 2025 and 2026. He submits that in the

impugned order dated 16.06.2026 (Annex. P/7), although the respondents extended the petitioner's contract until 03.06.2027, however, they imposed an arbitrary condition requiring the petitioner to perform his duties at the Livestock Research Station, Chandan, District Jaisalmer from the 1st to the 23rd of every month, and to render services at the Centre for Conservation of Animal Biodiversity, Rajuwas, Bikaner for the remaining seven days. He contends that, being a contractual employee, the petitioner cannot be subjected to such an arbitrary requirement.

3. The matter requires consideration. Let notices be issued to the respondents. Issue notice of stay petition as well. Rule is made returnable within four weeks.

4. In the meanwhile and until the next date, the condition in the order dated 16.06.2026 (Annex.P/7) directing the petitioner to perform his duties as Teaching Associate at Livestock Research Station, Chandan, District Jaisalmer from 01st to 23rd of every month, shall remain stayed. The respondents shall permit the petitioner to discharge his duties at Centre for Conservation of Animal Biodiversity, Rajuwas, Bikaner.
