1. The matter comes up for orders on applications (I.A. Nos. 01/2026) filed by the petitioner seeking amendment/ correction in the cause title of the writ petition and the stay application, respectively.
2. Heard on the applications.
3. It is stated in the applications that, due to a bona fide and inadvertent typographical error on the part of the petitioner's counsel, name of respondent No. 2 was incorrectly mentioned in the cause title of the writ petition as well as stay application as **"Co-ordinator, P.T.E.T.-2026, Maharaja Ganga Singh University, Bikaner Rajasthan"** instead of **"Co-ordinator, P.T.E.T.-2026, Vardhaman Mahaveer Open University, Kota."** It is averred that the error is purely inadvertent and same does not affect the merits of the case, and that the proposed

amendment is confined only to the correction of the description of respondent No. 2 without introducing any new cause of action.

4. For the reasons mentioned in the applications, same are allowed. The petitioner is permitted to amend the cause title of the writ petition as well as stay application by substituting the description of respondent No. 2 from "**Co-ordinator, P.T.E.T.-2026, Maharaja Ganga Singh University, Bikaner (Rajasthan)**" to "**Co-ordinator, P.T.E.T.-2026, Vardhaman Mahaveer Open University, Kota**". The amended cause titles filed along with the applications shall be taken on record and placed at appropriate place.

5. The petitioner has moved another application (I.A. No.02/2026) seeking correction of the cause title in the order dated 16.07.2026.

6. Learned counsel for the petitioner submits that while passing the order dated 16.07.2026, the incorrect description of respondent No. 2, as mentioned in the original cause title of the writ petition due to an inadvertent typographical error, came to be reproduced in the order, therefore, it is prayed that the said clerical/typographical error occurring in the cause title of the order dated 16.07.2026 be also corrected.

7. For the reasons mentioned in the application, same is allowed. It is directed that wherever respondent No. 2 has been described in the cause title of the order dated 16.07.2026 as "**Co-ordinator, P.T.E.T.-2026, Maharaja Ganga Singh University, Bikaner, Rajasthan**", the same shall now be read as "**Co-**

**ordinator, P.T.E.T.-2026, Vardhaman Mahaveer Open
University, Kota."**

8. This order shall be treated as part and parcel of the order
dated 16.07.2026.
