1. One of the objections pointed out by the office pertains to non-filing of the certified copy of the order under appeal.

2. Learned Additional Advocate General submits that qua the impugned order several appeals are pending consideration before this Court including D.B. Special Appeal (W) No.769/2023 – State of Rajasthan Vs. Dalpat Singh Chundawat and in few cases certified copy of the impugned order has been filed, and therefore, requirement of filing of certified copy of the order under appeal may be dispensed with.

3. In view of the submissions made above, the requirement of filing of certified copy of the order impugned is dispensed with.

4. Though the office has pointed out several other defects, looking to the fact that several appeals are pending before this Court, the said defects are waived. Considering that the common issue arises for consideration, at the time of hearing, the record of D.B. Special Appeal (W) No.769/2023 shall be referred to.

5. Learned Additional Advocate General submits that in similar appeal being D.B. Special Appeal (W) No.769/2023, this Court relying upon the order passed by this Court at Jaipur Bench in D.B. Special Appeal (W) No.688/2023 and other connected appeals issued notices and granted interim protection.

7. Till the next date of hearing, effect, operation and execution of the impugned order shall remain stayed.
