Heard learned counsel for the parties.

2. The present application for interim Suspension of Sentence has been filed on the ground that the applicant-appellant's brother is getting married on 26.07.2026.
3. Learned counsel for the applicant-appellant submits that there is no other able member in the family who can take care of the arrangements of the marriage ceremony of applicant-appellant's brother. He further prays that sentence of the applicant-appellant may be suspended for a period of two weeks.
4. Learned Public Prosecutor has verified the fact of marriage of applicant-appellant's brother on 26.07.2026.

5. The verification report dated 18.07.2026 is taken on record.
6. Considering the facts and circumstances of the case, the present application seeking interim suspension of sentence is allowed and it is ordered that the substantive sentence vide judgment dated 19.08.2025 passed by learned Additional Sessions Judge, Pokran, District Jaisalmer in Session Case No.53/2023 against the applicant –**Kadu Khan S/o Khan Mohammad alias Khanu Khan**, shall remain temporarily suspended for a period of ten days from the date of his actual release provided he executes a personal bond in the sum of Rs.1,00,000/- (Rupees One Lakh Only) with two sureties in the sum of Rs.1,00,000/-(Rupees One Lakh Only) each (out of which one surety will be of his close relative) to the satisfaction of the concerned Jail Superintendent on usual conditions. He shall surrender back before the concerned Jail Superintendent after completion of ten days from the date of his actual release. The concerned Jail Superintendent shall give a date of his surrender.
7. Let this application seeking interim suspension of sentence be again listed on 04.08.2026, and on that date, learned Public Prosecutor and learned counsel for the applicant-appellant shall submit the compliance of this order.
