**Date of Pronouncement 07/08/2026**

01. उक्त सभी प्रकरणों में याचीगण द्वारा प्रत्यर्थी के आदेश दिनांक 10.07.2026 को इस आधार पर चुनौती दी गई है कि वे अल्प वेतन भोगी कर्मचारी हैं, उनका स्थानान्तरण एक स्थान से दूसरे स्थान पर किया गया। उक्त सभी प्रकरण एक ही आदेश से संबंधित होने से पूर्व में प्रकरणों को समेकित किया गया था, अब इनका एक साथ निस्तारण किया जा रहा है।

02. विद्वान अधिवक्तागण याचीगण की ओर से याचीगण का अल्प वेतन भोगी कर्मचारी होना और आदेश में टीए-डीए दिए जाने का उल्लेख नहीं होना और इस मामले में आदेश में प्रशासनिक कारणों से स्थानान्तरण करने का उल्लेख भी नहीं है। इस आधार पर आक्षेपित आदेश निरस्त कर पुनः समुचित आदेश पारित किए जाने के निर्देश दिए जाने की प्रार्थना की। इस संबंध में मेरा ध्यान Sharwan Kumar Vs The JDVVNL, S.B. Civil Writ Petition No. 2938/2024 व अन्य समान रिट याचिकाओं के निर्णय दिनांक 14.02.2025 की ओर आकर्षित किया तथा इस न्यायालय की जयपुर पीठ के न्यायिक दृष्टांत Faili Ram Meena Vs Rajasthan Rajya Vidyut Prasaran Nigam Limited S.B. Civil Writ Petition No. 12177/2026 के आदेश दिनांक 21.07.2026 की ओर ध्यान आकर्षित किया।

03. विद्वान अधिवक्ता प्रत्यर्थी की ओर से यह तर्क प्रस्तुत किया कि आक्षेपित आदेश में स्पष्ट रूप से यह अंकित है कि "In the interest of Nigam", ऐसी अवस्था में निगम के हितों में स्थानान्तरण किया गया है और इस आदेश में टीए-डीए दिए जाने से मना नहीं किया गया है। इस आदेश के तहत किए गए स्थानान्तरण में समस्त कर्मचारियों को टीए-डीए देय है और यह तर्क प्रस्तुत किया कि विद्वान अधिवक्ता याची की ओर से श्रवण कुमार व अन्य याचीगण (पूर्वोक्त) वाले मामले में पारित आदेश दिनांक 14.02.2025 व अन्य मामलों में पारित आदेश दिनांक 17.02.2025, 03.03.2025 में एकल पीठ द्वारा पैरा संख्या 15 व 16 में जो आदेश दिया गया, वह आदेश खण्ड पीठ द्वारा संशोधित कर उसमें यह स्पष्ट किया कि जो एकल पीठ द्वारा एक डिजीजन से बाहर स्थानान्तरण करने से रोक लगाई गई, उस हद तक आदेश निरस्त कर दिया गया और अपीलार्थी को प्रशासनिक आवश्यकताओं के अनुरूप स्थानान्तरण करने की छूट प्रदान की गई थी। इस संबंध में D.B. Spl. Appl. Writ No. 854/2025, Ajmer Vidyut Vitran Nigam Limited & Ors. Vs. Isak Khan व अन्य D.B. Spl. Appl. Writ याचिकाओं के निर्णय दिनांक 20.01.2026 की ओर ध्यान आकर्षित किया।

04. मैंने उपर्युक्त न्यायिक दृष्टांतों पर विचार किया। जहां तक इस न्यायालय की जयपुर पीठ के फैली राम मीणा (पूर्वोक्त) वाले मामले में पारित अंतरिम आदेश का प्रश्न है, यह प्रकरण अंतिम आदेश न होकर अंतरिम आदेश की श्रेणी में आता है, जिसमें



कोई विधिक स्थिति स्पष्ट नहीं की गई है। जिसका कोई लाभ हस्तगत मामले में प्राप्त करने के याचीगण अधिकारी नहीं है और जहां तक श्रवण कुमार वाले मामले व उससे संबंधित अन्य मामलों में पारित आदेश दिनांक 14.02.2025 का प्रश्न है, इस आदेश में मुख्य रूप से पूर्व आदेश निरस्त करते हुए पुनः विचार करने का आदेश दिया गया था और एक ही डिवीजन में स्थानान्तरण करने के निर्देश दिए गए थे, जो इस न्यायालय की खण्ड पीठ द्वारा AVVNL & Ors. Vs. Isak Khan (पूर्वोक्त) व अन्य D.B. Spl. Appl. Writ याचिकाओं में पारित निर्णय दिनांक 20.01.2026 के द्वारा एकल पीठ के इस आदेश को निरस्त कर दिया गया कि जिस डिवीजन का कर्मचारी है उस डिवीजन में ही स्थानान्तरण किया जाए।

05. ऐसी अवस्था में एक डिवीजन से दूसरे डिवीजन में स्थानान्तरण करने का अधिकार प्रत्यर्थी को होना D.B. Spl. Appl. Writ याचिकाओं के निर्णयों से स्पष्ट है। इस मामले में एक डिवीजन से दूसरे डिवीजन में भी स्थानान्तरण किए गए हैं, जहां तक टीए-डीए दिए जाने का प्रश्न है, इस आक्षेपित आदेश द्वारा टीए-डीए दिए जाने से इन्कार नहीं किया गया है और आदेश में "In the interest of Nigam" स्थानान्तरण किए जाने का उल्लेख है, जो यह नहीं माना जा सकता है कि प्रशासनिक कारणों से स्थानान्तरण न किए गए हों और इस आदेश का अर्थ यह नहीं निकला जा सकता कि कर्मचारियों की सहमति से आदेश पारित किया गया हो, बल्कि यह आदेश स्पष्ट रूप से निगम के हित को ध्यान में रखते हुए ही किया जाना स्पष्ट है। जिसमें आदेशानुसार ही टीए-डीए स्वतः देय है और विद्वान अधिवक्ता प्रत्यर्थी द्वारा भी यह तर्क प्रस्तुत किया कि इस आदेश में किए गए स्थानान्तरण से प्रभावित कर्मचारियों को नियमानुसार टीए-डीए देय होगा। ऐसी अवस्था में जो आधार आक्षेपित आदेश को निरस्त करने के लिए, लिए गए हैं, वे न्यायोचित नहीं हैं। आदेश स्पष्ट है और पूर्व में वर्णित खण्ड पीठ के आदेशानुसार एक डिवीजन से दूसरे डिवीजन में स्थानान्तरण करने का अधिकार प्रत्यर्थी को हासिल है और निगम के हित में स्थानान्तरण किए जाने से टीए-डीए भी देय हैं और केवल मात्र इस आधार पर कि याचीगण अल्पवेतन भोगी कर्मचारी है, आक्षेपित आदेश निरस्त नहीं किया जा सकता। अतः याचीगण की याचिकाएं निरस्त किए जाने योग्य हैं।

06. लिहाजा याचीगण की ओर से प्रस्तुत ये सिविल रिट याचिकाएं निरस्त की जाती हैं एवं इन रिट याचिकाओं के साथ प्रस्तुत स्थगन प्रार्थना-पत्र भी निस्तारित समझे जाएं।
