1. Learned counsel for the petitioner submits that though a chance was given to the petitioner to complete the evidence vide order dated 11.07.2023 passed by a Coordinate Bench of this Hon'ble Court in S.B. Civil Writ Petition No.17765/2019, but despite such opportunity, the petitioner could not complete the same, due to the extreme flood like condition in Himachal Pradesh.
2. In such extraordinary circumstances, issue notice to the respondents, returnable on 06.12.2023.
3. In the meanwhile and in the interest of justice, one last chance is given to the petitioner to produce his witness before the learned trial court on the next date fixed before it. Such opportunity is, however, granted subject to deposition of a cost of Rs.25,000/- before the learned trial court.
4. Such cost, upon being deposited, be released equitably in favour of the contesting respondent (s).

5. In case the respondents refuse to accept such cost, further proceedings in civil original suit no.159/2013 pending before learned Additional District Court No.1, Anoopgarh, shall remain stayed.

6. It is made clear that in case, the petitioner fails to utilize the aforesaid opportunity, this order shall automatically stand nullified.
