1. This writ petition has been filed by the petitioner with following prayers:-

(i) The respondents may kindly be directed to grant the First & Second selection scale on completion of 9 & 18 years of service from the date of his initial appointment (05.03.1997) it becomes due along with arrear of salary and interest thereon @18%,

(ii) The respondents may kindly be directed to grant the third selection scale on completion of 27 years of service from the date of initial appointment it becomes due along with arrear of salary and interest thereon @18%.

(iii) The respondents further directed to grant the arrear of salary for the selection scales on completion of 9,18 and 27 years of service from the date it actually become due along with 18% interest.

(iv) Any other appropriate writ, order or direction which this Hon'ble Court deems just and proper may kindly be passed in favour of the petitioner.

2. Issue notice.

3. Mr. Shankar Singh, advocate is directed to accept notice on behalf of respondents. Service upon respondents is therefore, complete.

4. Learned counsel for petitioner while referring order dated **03.05.2023** in **S.B. Civil Writ Petition No. 6074/2023** titled as **"Bhanwar Nath and Ors. Vs. Rajasthan State Road Transport Corporation & Ors"** decided by a Co-ordinate Bench at Principal Seat, Jodhpur submits that the petitioner may be granted permission to file an appropriate representation before the respondents-Authority to consider and resolve his grievances in light to ratio decided on **25.01.2017** in **S.B. Civil Writ Petition No. 8810/2014 "Tara Chand Vs. Rajasthan State Road Transport Corporation & Anr."**

5. Considered the grievance raised herein, the petitioner is given a liberty to submit a representation to the respondents-Authority within a period of 30 days raising all grounds and the respondents-Authority are directed to decide the representation in light of ratio as laid down in case of **Tara Chand Vs. Rajasthan State Road Transport Corporation (supra)**, and relied in **case of Bhanwar Nath and Ors. Vs. Rajasthan State Road Transport Corporation (supra)**. In case of deviation, the respondents are directed to decide the representation with a reasoned and speaking order within a period of 30 days from date of receipt of representation. After passing the order, the respondents are under an obligation to communicate the decision to the petitioner either by way of speed post or through E-mail, if petitioner has provided E-mail in his representation. If the

petitioner is still aggrieved, he has a liberty to approach this Court with fresh petition.

6. With the aforesaid directions, the present writ petition with pending application, if any, stands disposed of.
