1. D.B. Spl. Appl. Writ No.769/2023 alongwith connected matters at Jodhpur and D.B. Special Appeal Writ No.688/2023 alongwith connected matters at Jaipur Bench are taken up for analogous hearing.
2. We find that in this batch of appeals filed by the State, in some cases, applications for condonation of delay have been laid on which notices have been issued. There are cases wherein notices were issued but have remained unserved. Yet there are cases wherein service of notices is awaited. In some cases, though notices were submitted by the appellants, they could not be issued because those cases were tagged in the bunch of appeals.
3. In cases – D.B.S.A.W. Nos.791/2023, 856/2023, 860/2023, 863/2023, 865/2023, 867/2023, 869/2023, 874/2023, 876/2023, 879/2023, 886/2023, 889/2023, 924/2023, 936/2023, 955/2023, 971/2023, 1069/2023, 1084/2023, 1090/2023, 47/2024, 178/2024, 252/2024 at Jodhpur and D.B.S.A.W. No.293/2024 at

Jaipur Bench, wherein service of notices to respondent is still awaited, at the request of learned Advocate General, let fresh notices be issued to respondents on submission of notices within a period of four weeks. The notices are made returnable in four weeks.

4. In cases, where notices have been returned with the report that the addressee is not residing at the given address, fresh notice on present and correct address of respondent will have to be submitted within a period of four weeks. Notices are made returnable in four weeks.

5. In cases, where notices have been remained unserved for any other reason, (except on the ground that the noticee has been reported to be dead) fresh notices may be issued within a period of four weeks, returnable in four weeks.

6. In all those cases notices so far have not been issued, notices be submitted within a period of four weeks, returnable in four weeks.

7. List these appeals for further orders after eight weeks.
