1. Learned Additional Advocate General submits that qua the impugned order several appeals are pending consideration before this Court including D.B. Special Appeal (W) No.769/2023 – State

of Rajasthan Vs. Dalpat Singh Chundawat and in few cases certified copy of the impugned order has been filed, and therefore, requirement of filing of certified copy of the order under appeal may be dispensed with.

2. Though the office has pointed out several other defects, looking to the fact that several appeals are pending before this Court, the said defects are waived.
