1. Learned Senior counsel for the petitioner submits that the petitioner had passed orders dated 11.12.2023 (Annex.2) & 15.12.2023 (Annex.3) in the capacity of holding the post of Sub Divisional Officer at Suratgarh. He submits that being aggrieved of the said order, an appeal has been filed by Litchman & Ors. before the learned Revenue Appellate Authority, which is pending adjudication. He submits that the District Collector, Sri Ganganagar vide communication dated 02.06.2025 (Annex.9) has initiated an inquiry against the petitioner while observing that the petitioner in connivance with the Tehsildar, Patwari and the

applicant – Khushi Mohammad, has passed the orders dated 11.12.2023 (Annex.2) & 15.12.2023 (Annex.3) and thus, an inquiry is required to be initiated against the petitioner.

3. He submits that applicant – Khushi Mohammad has preferred SBCWP Nos.10862/2025 & 18078/2025 before this Court and the Coordinate Bench of this Court vide order dated 21.07.2025 had stayed the effect and operation of the order dated 02.06.2025 passed by the District Collector, Sri Ganganagar (Annex.13). He submits that once the effect and operation of the complete order has been stayed by the Coordinate Bench of this Court, the respondents could not have placed the petitioner under suspension taking into consideration the directions passed by the District Collector vide order dated 02.06.2025 (Annex.9). He also submits that till date the petitioner has not been served with the charge-sheet.

4. In view of the submissions made, issue notice. Issue notice of the stay application also.

5. In the meanwhile and till the next date, the effect and operation of the order dated 06.08.2025 (Annex.14) shall remain stayed.
