1. This writ petition in nature of PIL has been filed alleging that mining activity has been carried out on *gochar* land.

2. The respondents have filed their reply and it would be apposite to quote paragraph 3 & 4 thereof:-

*"3. That it is further submitted that the Respondents authorities had constituted various teams for the purpose of identification of Encroachments. The Revenue Team has pointed out that there are 5 encroachments in land bearing khasra no.735/5, in lands bearing khasra no.613 and 619 there are 2 & 7 encroachments respectively and in subject gochar land of village kharadi there are 74 encroachments in various khasras, however, no encroachment was found in khasra no.1180/1025 & 1102. Copy of the Mauka Fard & list of encroachers is submitted herewith and is marked as **Annexure-R/1** & **Annexure-R/2**.*

*4. That in pursuance of the identification of the Encroachments, the Respondent Authorities have issued Notices under Section 91 and have also issued bedakhli orders against the encroachers. Copies of the Notices and the Bedakhli Orders are submitted herewith and marked as **Annexure-R/3** & **Annexure-R/4**."*

3. Thus, the State has taken appropriate action in removing the encroachments. It is expected that the State shall remain vigilant that no further encroachments are made on the land.

4. With the aforesaid observations, the writ petition is disposed of.
