**HON'BLE DR. JUSTICE NUPUR BHATI**

**Order**

**SBCWP No.18536/2024:-**

1. Learned counsel for the petitioner submits that an application (I.A. No.01/2024) has been filed seeking correction/modification in the order dated 13.12.2024, whereby, interim order was granted by this Court, however, due to a typographical error, the interim order in the order dated 13.12.2024, was not recorded in the order-sheet.
2. Learned counsel for the petitioner, thus, urges that in the interest of justice, rectification/modification of the aforesaid order is essential.
3. For the reasons mentioned in the application (I.A. No.01/2024) and in the interest of justice, the same is allowed. The order dated 13.12.2024, passed by this Court, is modified and, from now on, shall be read as under:-
