1. Heard on application for condonation of delay.
2. Mr. Akhilesh Rajpurohit, learned counsel for the respondent submits that his name was not published in the cause list, so he came to know late regarding listing of the case, therefore, he may be granted some time to file reply to the application for condonation of delay.

3. Taking into consideration the fact that the appeal is delayed by 82 days and the cause shown, in the larger interest of justice and further taking into consideration that similar appeals have already been entertained on merits, we are not inclined to grant any other opportunity to file reply to application for condonation of delay. Therefore, application for condonation of delay is considered and allowed. Delay in filing the present appeal is condoned.
4. Since interim orders have been passed in all other connected appeals arising out of common order including D.B. Spl. Appl. Writ No.769/2023, in this case also, the effect and operation of impugned order shall remain in abeyance.
5. List the matter along with D.B. Spl. Appl. Writ No.769/2023.
6. Registry shall publish name of Mr. Akhilesh Rajpurohit as counsel for the respondent in the cause list. Further, name of Mr. D.L.R. Vyas shall not be published in the cause list as his name is wrongly published in the cause list.
7. Let a copy of memo of appeal be supplied to Mr. Akhilesh Rajpurohit today itself.
8. Learned counsel for the respondent is given liberty to apply for vacating the stay order.
