Having heard learned counsel for the parties, this Court finds that the dispute involved in the present criminal miscellaneous petitions pertains to matrimonial issues between the parties.

With a view to exploring the possibility of an amicable settlement of the disputes between the parties, this Court deems

it just and proper to refer the present matters to the Mediation Centre attached to the Rajasthan High Court, Jodhpur. The Secretary, Mediation Centre of the Rajasthan High Court, Jodhpur, is directed to appoint a trained mediator for an amicable settlement of the disputes between the parties.

The trained mediator shall submit his report to this Court on the next date of hearing, i.e., 22.09.2026.

The petitioners as well as respondent No.1 are directed to appear before the Mediation Centre on 11.09.2026 at 11:30 A.M.

On the aforesaid date, the trained mediator shall make an endeavour to resolve the disputes between the parties amicably in the spirit of Lok Adalat.

Re-notify these matters on 22.09.2026 along with the report of the trained mediator.

Interim order(s), if any, shall remain in force till the next date of hearing.
