1. These bail applications have been filed by petitioners under Section 483 of BNSS in connection with FIR No. 528/2025 registered at Police Station- Pratap Nagar (Udaipur), District- Udaipur for offences under Sections 115(2), 126(2) and 3(5) of BNS, 2025.

2. Heard counsel for petitioners, learned Public Prosecutor as well as counsel appearing on behalf of the complainant and perused the material available on record.

3. Having considered the contents of FIR and statements of injured Nathu Lal, there are omnibus allegations against several persons belonging to one family, to assault one Nathu Lal; there are no injuries from sharp edged weapon; injuries to Deepak, Rani, Son and Son-in-law of Nathu Lal are simple in nature; accused petitioner-Ram Chandra is 70 years old person and is in custody since 18.11.2025, accused-Shyam Lal is in custody since 15.11.2025 and two criminal antecedents against him are of year 2007 and 2024 for different nature of offences; accused-petitioners Rahul, Sharwan and Yashwant Singh Alias Guddu are in custody since 31.10.2025; the criminal antecedents of accused-petitioner Sharwan are of years prior to 2022 and one criminal antecedents of petitioner-Yashwant Singh Alias Guddu is of 2024 for petty nature of offences; accused-petitioners Suresh, Sunil, Ranjeet and Karan are stated to be in custody since 03.10.2025 and one criminal antecedent of accused-petitioner Suresh is of year 2022 for petty offence and one criminal antecedent of accused-petitioner-Sunil is under Section 9/11 of Prohibition of Smoking Act; there are no criminal antecedents of accused-petitioners Ranjeet and Karan; after investigation, charge-sheet has been filed and conclusion of trial may take considerable time, but without commenting on merits of the case, this Court deems it just and proper to release the petitioners on bail.

4. Accordingly, these bail applications are allowed and it is ordered that the accused-petitioners-(i)**Sharwan Kumar S/o Shri Ramchandra**, (ii) **Yashwant Singh Alias Guddu S/o Shri Sharwan Kumar**, (iii) **Rahul S/o Shri Sharwan Kumar**, (iv) **Shyamlal S/o Shri Ramchandra**, (v) **Suresh Alias Kaku S/o Ramchandra**, (vi) **Sunil Kumar Alias Dhuna S/o Ramchandra**, (vii) **Ranjit Alias Ranjeet S/o Pappu**, (viii) **Karan S/o Shyamlal & (ix) Ramchandra S/o Shri Pratap**, shall be released on bail provided each of them furnish a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing as and when called upon to do so.

5. However, considering the criminal antecedents of the petitioners, it is hereby directed that the petitioners shall not repeat the similar nature of offence and shall not tamper with/ threaten/ induce the prosecution witnesses, during bail granted by this Court. In case, breach of any of the condition is reported or comes to the notice of the Court, same shall be the reason for the trial Court to cancel the bail, granted by this Court.
