Considering the foregoing facts and circumstances and taking note of the fact that in a matrimonial issue entire family is implicated, it is directed that no coercive action/arrest shall be made against the petitioners, subject to their joining in the investigation and them marking appearance before the Investigating Officer concerned on 18.12.2025 at or around 11.00 am. The Investigating Officer is directed to adopt a mediation approach to settle the dispute at hand.
