1. Instant bail applications have been filed by petitioners under Section 483 of BNSS in connection with FIR No. 306/2025 registered at Police Station- Sadar Banswara, District- Banswara

for offence under Sections 115(2), 127(2), 140(3) and 308(2) of the BNS, 2023.

2. Heard counsel for petitioners as well as learned Public Prosecutor and perused the material available on record.

3. Having considered the allegations levelled against petitioners to kidnap the complainant, in order to demand some ransom and the fact that there are no criminal antecedents of petitioners; petitioners are in custody since 07.11.2025; Offences are triable by the Magistrate, but without commenting on merits of the case, this Court deems it just and proper to release the petitioners on bail.

4. Accordingly, the bail applications are allowed and it is ordered that the accused-petitioners- (i) **Manoj Alias Meenya Alias Manohar S/o Shankar Lal**, (ii) **Rahul S/o Kalia** and (iii) **Anil S/o Mangilal** shall be released on bail provided each of them furnishes a personal bond in the sum of Rs.50,000/- with two sureties of Rs.25,000/- each to the satisfaction of the learned trial Judge for their appearance before the court concerned on all the dates of hearing as and when called upon to do so.
