2. Learned counsel for the respondent-State Mining Department submits that there are violations and necessary action is being taken by the State and also the necessary reply and proceedings on behalf of the Mining Department have been filed on advance copy.
3. Issue notice.
4. Ms. Navya Sharma, for Mr. Mahaveer Bishnoi, AAG, accepts notice on behalf of respondent Nos. 1, 2, 3 & 4. Notices be sent to respondent Nos. 5, 6, 7 & 8, returnable within a period of four weeks.
5. In the meanwhile, taking into account Annexure-R2/5, it is directed that all kinds of mining activities at Mining Plot No. BJ-7/2024 near Village Akola, Tehsil Sawaipur, District Bhilwara shall remain stayed.
