1. Issue notice. Issue notice of the stay application as well.
2. In the meanwhile and until further orders, the effect and

operation of the impugned award dated 22.08.2025 passed by the Permanent Lok Adalat, Chittorgarh in Case No. 19/2022 titled Rijwana Begam & Ors. vs. Assistant Engineer, AVVNL & Anr. shall remain stayed, subject to the condition that the petitioner releases 60% of the decretal amount in favour of the claimants, Rijwana Begam & Ors., in conformity with the award dated 22.08.2025 passed by the learned Permanent Lok Adalat, Chittorgarh in the aforesaid case, within a period of six weeks from today.

3. It is made clear that in case the petitioner fails to release 60% of the decretal amount in favour of the claimants, Rijwana Begam & Ors., within a period of six weeks from today, the present interim order passed by this Court shall stand vacated automatically.
