1. Learned counsel for the petitioner submits that petitioner is presently posted as Teacher Grade-III, Level-II, Special Educator at Government Senior Secondary School, Amanpura, Block Gantiyali, District Phalodi. Counsel for the petitioner submits that the post upon which the petitioner is working has already been declared surplus and therefore, the respondents are about to transfer the petitioner to some other place. Counsel for the

petitioner submits that petitioner's husband is also a government servant and presently posted as Senior Assistant in PHED, Block Nohar, and therefore, makes a limited prayer to this Court to direct the respondents to consider the representation of the petitioner for her posting at the place where her husband is already posted. Counsel for the petitioner also submits that the post of Special Educator is already lying vacant in Nohar, Hanumangarh.

2. In view of the limited submission made, the writ petition is disposed of with the direction to the petitioner to file appropriate representation to the respondent No.3 who shall consider the peculiar facts of the petitioner's case and pass an order for posting the petitioner in an objective and sympathetic manner and in view of the guidelines/circulars issued by the State of Rajasthan from time to time in relation to the situations where husband and wife both are government servant.

3. On representation being made by the petitioner, the same shall be decided strictly in accordance with law within a period of 30 days from the date of representation, by a reasoned and speaking order.

4. With these observations, the present writ petition stands disposed of. Stay petition and all pending applications stand disposed of.
