By way of these criminal misc. petitions under Section 528 of BNSS, the accused-petitioners have approached this Court with a prayer to quash the FIR No.383/2025 registered at Police Station Sadar Bundi, District Bundi (Raj.) for offences punishable under Sections 318(4), 338, 336(3) & 340(2) of the Bharatiya Nyaya Sanhita, (in short 'BNS') 2023.
