1. S.B. Civil Miscellaneous Appeal No. 298/2021.

Matter has come up on an application bearing Inward No.1/2021 filed on behalf of the respondent-claimant for modification in the interim order dated 11.02.2021 passed by this Court.

For the reasons stated therein, the application is allowed and the order dated 11.02.2021 about the withdrawal of 60% out of the

said deposit amount is modified to the extent that 30% of the deposited award amount shall be disbursed on furnishing a solvent surety and 30% on furnishing an undertaking on oath. Rest part of the order dated 11.02.2021 shall remain as it is.

The application stands disposed of.

Matter has come up on an application bearing Inward No.1/2021 filed on behalf of the respondents-claimants for modification in the interim order dated 11.02.2021 passed by this Court.

For the reasons stated therein, the application is allowed and the order dated 11.02.2021 about the withdrawal of 50% out of the said deposit amount is modified to the extent that 20% of the deposited award amount shall be disbursed on furnishing a solvent surety and 30% on furnishing an undertaking on oath. Rest part of the order dated 11.02.2021 shall remain as it is.
