While deciding the present batch of writ petitions, this Court in Para-24 of order dated 25.02.2026 directed the respondents to conduct a fact finding inquiry so as to examine the allegations of discrimination and manipulations made by the petitioners in their respective petitions and further directions were given that upon inquiry, in case, it is found that certain persons have been given appointment contrary to the Rules and then after affording opportunity of hearing, necessary action shall be taken in accordance with law. Three months time was granted by this Court to carry out the necessary exercise as per directions given in order dated 25.02.2026. More than six months have lapsed since then.

Learned counsel appearing for the respondents submits that the respondents are actively considering the directions and are in the process of making verification of the candidates. Total 648 candidates were there against whom such allegations were levelled, out of which 193 never joined and 23 candidates have already resigned. Remaining candidates are under scrutiny and the respondents are going to take action against them.

Learned counsel for the respondents prays for 30 days' more time for completing the exercise. Looking to the facts stated in affidavit dated 31.08.2026, this Court grants 30 days' more time to the respondents to do the needful as per directions given in order dated 25.02.2026.

It is made clear that in case, the complete compliance is not made within a period of 30 days, Director General, Central Reserve Police Force (CRPF), New Delhi and Director General, Central Industrial Security Force (CISF) shall remain personally present before this Court to explain the reasons of non-compliance along with their personal affidavits.

Let these matters be listed on 14.10.2026.
