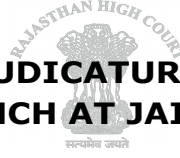

आदेश 39 नियम 1 व 2 सी.पी.सी. के आवेदन पर विद्वान विचारण न्यायालय ने दिनांक 31.01.2026 को आदेश पारित करते हुए अन्तरित आदेश से इंकार किया है जिसके विरुद्ध यह अपील पेश की गयी है।

विद्वान अधिवक्ता अपीलार्थी का निवेदन है कि इस स्टेज पर इस अपील को प्रेस नहीं करते हैं, लेकिन आदेश 39 नियम 1 व 2 सी.पी.सी. के प्रकरण को निर्धारित अवधि में निस्तारित किये जाने का निर्देश प्रदान किये जाने का निवेदन किया।
