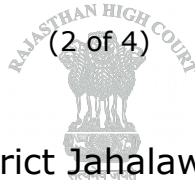

1. It has been submitted by petitioners that entire amount under recovery notice has been paid, but Senior Counsel for respondents, although admits deposition of amount by petitioners yet states that full amount has not been paid and details have been mentioned in the reply to the writ petition.
2. Counsel for petitioners prays for and is granted three weeks' time to file rejoinder/ additional affidavit in respect of outstanding dues, if any, against petitioners, after adjustment of the amount paid by him and recovered by the respondents.
3. In the meanwhile, no coercive action against petitioners, pursuant to the impugned recovery notice dated 31.03.2022, be taken till next date.
