The present writ petition has been filed challenging the order dated 13.11.2025 passed by the learned Senior Civil Judge, Jaipur Metropolitan-I, Jaipur in Reference Case No.16/2012, titled as Amarsingh Vs. Pushpa Devi and Ors., vide which the application dated 21.09.2012, along with two other applications dated 19.03.2025 and 01.04.2025 filed under Section 151 of the Civil Procedure Code, 1908, has been allowed and the applicants therein have been impleaded as parties in the reference case.

Mr. L.L. Gupta, learned counsel for the petitioners, at the very outset, submits that there was no occasion whatsoever for allowing the said application, as on a bare perusal of the communication dated 16.03.2012, vide which the reference was sent by the Land Acquisition Officer to the Civil Court, the basis for making the said reference was the pendency of Revenue Suit No.74/92, titled as Chawand Singh Vs. Hamir Singh, whereas the said suit itself has been dismissed on 15.03.2024.

Learned counsel further submits that despite the factum of the dismissal of the said revenue suit having been specifically brought to the notice of the Court below, the said objection was brushed aside merely on account of an appeal having been filed against the said order, though no details of the same were stated therein.

Learned counsel also submits that under no circumstances, the applicants could have been treated either as necessary or proper parties so as to allow the application for impleadment.

Taking note of the above, issue notice to the respondents returnable within six weeks. Notices be also sent through registered post in addition to the normal process.

Notices be given '*dasti*' to learned counsel for the petitioners.

List the matter on 19.05.2026.

Till the next date, the effect and operation of the order dated 13.11.2025 passed in Reference Case No.16/2012 shall remain stayed.
