Ms. Vandana Sharma appears on behalf of Mr. GS Gill, learned Additional Advocate General. She submits that due to Assembly Election in the State of Rajasthan on 7th December, 2018, the Principal Secretary, Revenue Department, Jaipur, is unable to appear before the court thus these cases may be listed after 11th December, 2018.

The prayer aforesaid is accepted. Let these cases be listed on 13th December, 2018 to seek compliance report from the Revenue Department pursuant to the directions of the court.

The Revenue Department is directed to come with information as to how much area falls in the catchment of "Ramgarh Dam" and out of it, how much area is under the Jaipur Development Authority, Jaipur. They would further inform about encroachment in the area falling under the JDA and remaining area. The information aforesaid would be brought along with compliance report on the next date of hearing.

It is made clear that information aforesaid would be in reference to the Revenue Record of the year 1955.

For the purpose of compliance report from the Municipal Corporation, Jaipur, let these cases be listed tomorrow i.e. 5th December, 2018 and thereupon, on 6th December, 2018 seeking compliance report from the Jaipur Development Authority and thereafter, on 13th December, 2018 to seek compliance report from the Revenue Department.
